2. Place of employment and address?
3. Current phone number, home and work?
4. May we leave a recorded message at either number?
5. With whom do you presently reside, and what is their relationship to you (son, husband, friend, etc.)?
6. During what periods of time, if any, have you resided in St. Charles County during the last five years?
7. Since the entry of your child support order, has (have) your child(ren) resided with the non-custodial parent or anyone else for a period of time greater than thirty consecutive days (not counting court-ordered visitation)? If so, when and for how long?
8. How often does your child see the non-custodial parent?
9. Are you aware of any court order that may have terminated the non-custodial parent's legal obligation to provide support? If yes, please explain.
10. Have you made any other agreements or arrangements with the non-custodial parent regarding their payment of child support? If yes, when and what?
11. Has the non-custodial parent ever paid child support directly to you (i.e., without going through a circuit clerk's office or F.S.P.C.)? If so, when and how much?
12. Have you ever waived all or part of the child support arrears owed?
13. In the last five years, has the non-custodial parent ever provided support for your child(ren) not in the form of money (e.g., help with food, clothing, shelter, schooling, medical bills, etc.)? If yes, when and for what purpose?
14. Are you currently working with Support Kids for the collection of your child support?
15. Should your case be considered for criminal prosecution, it is possible the non-custodial parent may face a period of incarceration (prison or jail). With this in mind, will you be willing to testify and otherwise cooperate with our office in enforcing the laws of the State of Missouri?
16. Is your child / Are any of your children emancipated (i.e., over the age of 18 and not attending high school, OR not enrolled in college the fall after graduation from high school, OR in the military, OR married)? If so, since when?

17. List everything you know about the non-custodial parent's employment and/or the source of his/her income.
  
18. List the names and addresses of people who may have knowledge of the non-custodial parent's employment, habits, and recreational activities.
  
19. Are you aware of the non-custodial parent receiving other forms of benefits (e.g., social security, retirement, veterans' benefits, etc.)? If so, what?
  
20. Has your child support case ever been modified? If yes, when?
  
21. Has any enforcement action been filed against the non-custodial parent pertaining to the child in this case? If so, when and where was the action filed, and what was the disposition?
  
22. To the best of your knowledge, has the non-custodial parent been incarcerated or imprisoned at any time during the last five years? If so, please list the dates, locations and the reason(s) for incarceration.
  
23. Are you aware of any medical, physical, or mental condition that would prevent the non-custodial parent from paying child support? If so, please explain.
  
24. Does your child have any extraordinary medical or school needs of which we need to be made aware? Please explain.
  
25. Why are you requesting action in this matter, and what is your hope for the outcome of this case?
